Alliance Pipeline L.P. files application for Three Rivers Interconnection Project

On April 1, 2021, Alliance Pipeline L.P. ("Alliance") filed with the Federal Energy Regulatory Commission ("FERC") an Abbreviated Application for a Certificate of Public Convenience and Necessity regarding its proposed Three Rivers Interconnection Project ("Project") in FERC Docket No. CP21-113-000 ("Application").

The Application seeks approval for Alliance to construct, install, own, operate, and maintain approximately 2.85 miles of 20-inch diameter natural gas pipeline, a new metering and regulating station, and other related auxiliary facilities and appurtenances to provide natural gas transportation service to Competitive Power Ventures' (CPV) planned Three Rivers Energy Center in Grundy County, Illinois. The proposed Project originates at Alliance's existing 36-inch pipeline in the Village of Channahon (east of the Aux Sable Liquids Product facility), travels beneath the Illinois River and terminates in an industrial area along E. Collins Road in Goose Lake Township

(approximately one and a half miles south of the Illinois River).

The auxiliary facilities consist of launcher and receiver facilities at the beginning and terminus of Alliance's proposed 20-inch pipeline. The new metering station, which is required to measure gas quality and volumetric flow to the customer, will be built at the terminus of the 20-inch pipeline. If approved, the 20-inch pipeline is anticipated to be in service in the third quarter of 2022 and be capable of delivering approximately 210 million standard cubic feet per day of natural gas.

Notice of the Application will be mailed to affected landowners, and municipal, state and federal governments and agencies involved in the Project. A copy of the Application and related resource reports are on file in the following public libraries:
